6. Community Information & Services

Update on Post Office services in the Village provided by Cllr Dr Livas-Dawes. BT are due to test the system on Tuesday 7th November and subject to this the Post Office would be open for business from Thursday 9th November between 9:30am and 12 noon.

Tree work in Cemetery and Blacksmiths Corner – Cllr Longhorn will contact Mick Wilkin to see if he has the correct equipment to carry out the work and report back to the PC. Suggestion of Audio book for the villages – Cllr Dr Livas-Dawes. This is an item SKEALS are working on and it was agreed that the group are best placed to produce such work. Citizen Link Unit – Discussion took place about the potential cost of the work and also the ongoing cost of maintaining and running if it were to be developed as a public toilet. Councillors were asked to consider the issue for further discussion at the next meeting.

7. Enhancement Fund Application

Allocation criteria was raised, however Karen Wood advised that the funds transferred would not be for distribution by the Parish Council, but for use to action items identified in the Parish Plan.

An Application from Friends of Easington Primary School has been received.

8. Yorkshire Wildlife Trust Visitor Centre

Spurn Liaison group had met and notes from the meeting were to be circulated to the PC – It is not yet confirmed if the group would continue. There is concern that the car park has been constructed using Type 1 but should be Type 3 as per agreements, which is holding water. This would be picked up by Cllr I Smith and Ward Councillor Tucker.
